Born in Tokmok (now Kyrgystan), on December 18,1990.A highlight in his amateur boxing experience is the gold medal he got in the World Combat Games in San Petersburg in 2013. His professional debut was the following year, beating Uruguayan Jorge Rodriguez by TKO in Moscow. In his fourth fight he disputed his first regional crown with the WBC and on November 4 of 2015 (his 5th fight) he got the Inter Continental Title of the 175 lbs division by beating Brazilian Jackson Junior by KO 4. Two fights later he had the chance at the interim crown held by Dominican Felix Valera, whom he defeated by UD on May 21, 2016 in Moscow. Bivol was elevated to regular champion and has made five defenses of his title.







Thereafter, Inoue successfully defended the title on two occasions, and holds a professional record of 18wins, 0 losses, with 16 knockouts, including those recently as part of the World Boxing Super Series over Juan Carlos Payano and Emmanuel Rodriguez. Inoue previously held the Light Flyweight and Super Flyweight world titles.
