## **WBA REGIONAL TITLES SANCTION FEES (INTERCONTINENTAL – INTERNATIONAL – CONTINENTAL – CONTINENTAL GOLD – CONTINENTAL EUROPE) AND FEES FOR WBA OFFICIALS**

**EFFECTIVE FROM JUNE 01, 2024**

### **WBA REGIONAL TITLES SANCTION FEES (INTERCONTINENTAL – INTERNATIONAL – CONTINENTAL – CONTINENTAL GOLD):**

- Annual Promoter's License (if not affiliated with the WBA) - €500
- Sanction Fee: EURO 5,000.00
- Belt: EURO – 1,150.00

Promoters are responsible for paying the shipment costs of the belt.

If the championship belt changes hands, the Promoter of the event is responsible for payment and shipping of the belt to the new champion.

Officials' payment should be made during the official weigh-in and rules meeting.

#### **AMOUNT TO PAY:**

- Supervisor: €700
- Judges (each) €700
- Referee €700

### **WBA CONTINENTAL EUROPE TITLE SANCTION FEES:**

- Annual Promoter's License (if not affiliated with the WBA) - €500
- Sanction Fee: EURO 4,000.00
- Belt: EURO – 900.00

Promoters are responsible for paying the shipment costs of the belt.

If the championship belt changes hands, the Promoter of the event is responsible for payment and shipping of the belt to the new champion.

Officials' payment should be made during the official weigh-in and rules meeting.

#### **AMOUNT TO PAY:**

- Supervisor: €600
- Judges (each) €600
- Referee €600

## TRAVEL

The Promoter will be responsible for arranging transportation for the Supervisor and Officials to arrive three days before the event.

It's important to note that, as with all WBA events, the Promoter must cover the costs to cover the travel expenses for the Referee, Judges, and the Supervisor, first-class hotel, and all meals.

The expenses for meals should not be less than 50 Euros per day.

## OTHER

The appointed Officials must have a valid license from a recognized National Boxing Commission in the country where they are licensed.

Additionally, all other fees or costs related to holding a WBA Title event, including any local government or Sport Commission requirements, will be the responsibility of the Promoter.
